# A Business-Law Perspective on Global Mobility, Corporate Growth, and Competitive Strategy

## Block 1, The Changing Global Landscape (11:10 AM - 12PM) - Law

Immigration law has evolved into a key component of modern business law and global corporate strategy. The presentation will examine how businesses rely on immigration frameworks, such as sponsor licences, skilled worker visas, and global mobility routes, to expand internationally, attract talent, and remain competitive in global markets. The talk will also discuss the growing importance of immigration compliance within corporate governance, risk management, and business operations, highlighting how legal mobility frameworks influence innovation, investment, and commercial growth. Participants will be encouraged to engage in short interactive activities throughout the session, where they will write down key pointers, insights, and business-law connections they identify from the presentation. These activities are designed to promote critical thinking and encourage discussion around the relationship between immigration law, global mobility, and business expansion.

# Data, Decisions, and the Limits of AI Agents; building AI scepticism in case studies

The session will provide an overview of the deployment of 22 AI agents and a custom ChatGPT to bridge employer requirement for AI proficiency and critical evaluation. It will introduce the use of stakeholder mapping, roleplay and Socratic questioning to position students as the most knowledgeable other.

# The Changing Global Landscape - A Live Global Strategy Simulation

## Block 1, The Changing Global Landscape (11:10 AM - 12PM) - Business

“The Changing Global Landscape” is an interactive session exploring how rapid shifts in global politics, technology, economics, sustainability, AI, and international relations are reshaping business, law, entrepreneurship, and society. Rather than a traditional lecture, the session will use a live country-representation simulation where selected audience participants act as strategic representatives of different nations (China, UK, and USA).

Through guided scenarios, discussions, and quick decision-making exercises, participants will explore how global events, innovation, trade, regulation, talent mobility, ESG pressures, and AI advancement influence international business and legal environments.

The session aims to help students: understand the interconnected nature of the modern global economy; think critically about emerging global opportunities and risks; recognise how geopolitics and technology influence business and law; appreciate the growing importance of ethical leadership, sustainability, and adaptability in a rapidly changing world.

Participants can expect: a highly interactive and discussion-based experience; live audience participation and role-play; short strategic decision-making activities; practical business and global insights; audience Q&A and reflection.

# Language, Voice and Futures: Why Multilingualism Matters (and Why It's Never Too Late)

## Block 1, The Changing Global Landscape (11:10 AM - 12PM) - Languages

Language shapes our understanding, voice and professional futures, and multilingualism is an expandable resource. Drawing on examples from public life, we challenge the idea that language learning only matters if started early or pursued to native-like fluency. Instead, let's present multilingualism as something we can grow into at any stage, supporting confidence, belonging and professional agency in a global society. The session will reflect on how languages function as tools for participation and connection across different contexts and why engaging with additional languages (even at basic or intermediate levels) can open opportunities. There will be brief interactive moments encouraging reflection on language use and aspirations as an invitation to consider how language experience can shape our voices and futures.

## Dr Marina Micke

The University of Law, Head of Modern Languages

Marina Micke is a specialist in German language education and assessment in higher education, with particular expertise in curriculum design and language provision for international and professional contexts. Her work focuses on inclusive teaching and assessment through Universal Design for Learning, technology-enhanced language learning, and the growing impact of artificial intelligence on language education, communication and assessment.

In her current role as Head of Modern Languages, she is excited to create language learning opportunities across the University of Law and is keen to engage with students about their diverse backgrounds and experiences.

# Rethinking Academic English for Today's ULaw Students

## Block 1, The Changing Global Landscape (11:10 AM - 12PM) - Languages

As the University of Law becomes increasingly diverse, including more international students, English for Academic purposes provision should move beyond a deficit model, realising that having more than one language in your learning tool kit is in fact an advantage to be exploited. In rethinking our approach, we are looking to review current provisions and embed English language learning materials that can benefit all student populations, whilst supporting EAL in particular. This will involve an exploration of learning and teaching practices, as well as assessment themes and academic integrity practice and policy. This session will focus on what this might look like in practice, what we predict will work, and what still needs to be resolved.

## Rachel Barker

The University of Law, Academic English Language Manager

**“Your languages are not a problem to fix but a resource to build on—and academic English should be part of your learning, not separate from it.”**

After living and working in Asia for over a decade, I have been working in the UK HE sector for 6 years, exclusively with international students. Having been through the challenges of adapting to another country's education, I bring lived experience as well as academic underpinning to my learning and teaching strategies.

# AI Did Not Take the Responsibility, We Gave It Away

## Block 1, The Changing Global Landscape (11:10 AM - 12PM) - Student-led Change

One of the most urgent and overlooked risks of the AI era is the illusion that automation transfers responsibility. As AI systems increasingly influence decisions in education, healthcare, employment, finance, and public services, organisations often assume that accountability rests with the technology, the vendor, or the policy framework. It does not.

When an algorithm screens a job candidate, flags a student, prioritises a patient, or influences a financial decision, accountability does not transfer to the machine. It concentrates in the hands of whoever chose to deploy it. Drawing from industry governance, privacy, and security experience, Yunique examines why humans consistently over-trust automated outputs, how shadow AI is spreading inside institutions without oversight, and why every automated decision must have a clearly defined human owner.

Through real cases across hiring, healthcare, housing, and law enforcement, this session exposes the gap between how organisations talk about AI governance and how they actually practise it — and what it looks like when accountability structures are built for the AI era, not retrofitted after harm has already occurred. Grounded in current legal frameworks including GDPR, the EU AI Act, and UK equality law, the session makes the case that the law is not behind. Institutional behaviour is. The next generation of lawyers, executives, and public leaders will either close that gap or widen it.

The core message is direct: AI did not take responsibility away from us. We handed it over — through rushed deployment, deliberate opacity, and the comfortable fiction that the algorithm decided. Taking it back requires governance that is operational, not performative.

## Yunique Demann

Yunique AI, Founder & CEO

**“Conversations about AI often focus on what the technology can do, while overlooking what it means for accountability, trust, and human decision-making. I hope attendees leave with a deeper understanding that responsible AI is not just a technical issue — it’s a business, legal, and societal one.”**

Yunique Demann is an AI governance strategist, privacy professional, and former security leader specializing in the intersection of AI, law, privacy, and organizational accountability. As the founder of Yunique AI, she helps organizations build AI systems that are not only innovative, but legally defensible, operationally responsible, and human-centred. She is the creator of the CLEAR™ framework for organizational AI governance and the VOICE™ framework for AI literacy, and the author of the forthcoming book, *The App Is Not Your Friend*. With experience leading governance initiatives across global organizations, her work focuses on transforming governance from a compliance exercise into a practical framework for trust, accountability, and ethical decision-making in the age of automation.

He is a member of the Common Futures Conversations at Chatham House London and contributes to shaping the future of national media strategy as a member of the Long-Term Strategy Steering Group at the Student Publication Association.

# Your AI, Your Future

### MEET THE PANELLISTS



#### Patrick Grant

The University of Law, Associate Professor AI and Technology

AI is reshaping every industry including the law. In this panel, we will explore how AI is opening access to justice for people who've historically been locked out of the legal system, and what that means for the students who'll be working with these tools tomorrow.

**“AI is the defining challenge of our generation, and the students in this room are the ones who'll shape it. I want to be part of that conversation”**

Patrick is the University of Law's first Associate Professor by job role, recognised for his leading work in legal technology and education. A non-practising solicitor with a Masters in Law and Economics from the Universities of Bologna and Gent, he joined the University's Leeds campus in 2017 and has since led the creation of the University's Legal and Technology Hub in Leeds, connecting the legal sector, business, and local government.

He has also developed LLB Tech modules and AI training, teaches across Criminal Law, Common Law Method, and Intellectual Property, and regularly speaks and writes on AI, legal tech, and access to justice.



#### Vipul Ladwa

Casey, Co-Founder

The ethics debate has become more performative than practical, meanwhile, lawyers are already using AI every day. The question of whether AI should be used in law has been long surpassed, and has now become whether it is being used in a way a lawyer can professionally stand behind. Having spent a decade advising the companies building AI on liability frameworks, and now building AI for the firms using it, the conversation I hear inside law firms is not about regulation or ethics, it is about accountability: if this gets it wrong, what happens to me? AI is just a tool -powerful, useful, and never a substitute for judgment. The lawyers who understand that distinction are the ones that are really delivering value to their clients.

**“Law is at an inflection point and I want to talk honestly about what that means for the people entering this profession. I'm joining this conference to share what I've seen from both sides: as a lawyer who watched AI reshape the industry, and as a founder building what comes next.”**

Vipul is Co-Founder and CEO of Casey, a legal AI platform that enables law firms to productise their expertise and deliver AI-powered legal services directly to clients. A former technology lawyer at DLA Piper, he spent over a decade advising on AI regulation, machine learning, and emerging technology. He is a recognised member of the UK LawTech Advisory Board and a 2026 LegalTechTalk LaunchPad finalist.



#### Dr Marina Micke

AI is already transforming how we work, but it remains a tool whose value depends on how we use it. In language learning, its greatest potential lies in supporting access and boosting confidence. We should not mistake this as a sign that AI will replace the fundamentally human act of communicating with others to understand and be understood. Like in law, the real value comes from recognising that AI can enhance human capability and realising that it cannot replace the individual's judgment, ability to build connections, create and convey meaning.

Anyone who wishes to improve outcomes for the people and communities we serve, soon runs into the familiar problems of staffing and budgetary shortages, rising expectations and falling public satisfaction with services.

We will discuss reforms to police training and the acute challenges of shrinking budgets and staff numbers and managing working relationships between volunteers and paid staff.

New technology has limits when driving change, but good leadership can successfully overcome these challenges to build teams effectively, create the right working environment, emphasise the importance of culture, discipline and standards, and change toxic team identities with the aim of leading change in the wider public sector.

My journey into law began with my undergraduate degree in Ancient History at the University of Liverpool. I found myself enjoying the study of ancient Roman laws and their socio-economic impacts on marginalised groups, much more interesting than any other content I had been learning. Once I graduated, I quickly decided to take on the MA Law Conversion at the University of Law, while working full/part time hours. During the first month of my studies at ULaw, I applied for a training contract at Bevan Brittan (BB), where I am now a 2nd seat trainee in the Litigation and Procurement department.

After finishing my Law conversion and with the support of BB, I went on to take the SQE, which I passed first time after many hours of study.

My journey into law wasn't the most traditional and I understand the struggle and stress of balancing full-time study and full-time work. The jump from academia to legal practice can be daunting, so I will be sharing my own experiences and tips to help prepare you for your training contract.

# Business consultancy projects for enhanced graduate employability

**Block 4, Bridging academic study with professional practice (14:50PM - 15:40PM) - Business**

A recent ISE Student Development Survey highlights that employers are concerned that graduates are less prepared for the workplace than in previous years, lacking essential communication and interpersonal skills (Institute of Student Employers, May 2025). Employers comment that graduates don't meet expectations in self-awareness and misrepresent their skills using AI.

Graduates who have completed an internship or placement, however, are reported to have better skills and attitudes, since this work experience helped graduates develop skills that are essential for the workplace (Times Higher Education, May 2025). University leaders are aware that there exists a gap between the competencies graduates have upon leaving university and the needs of employers. It is essential that students are better engaged with employers while they are at university, and this engagement must be embedded into the curriculum.

ULaw Business School plans to offer a range of business consultancy services from current students to local businesses, supported by academic staff who have specialist expertise in a range of valuable topics. This initiative benefits local businesses by providing access to fresh, innovative thinking, while our students gain from live projects with real clients. Participants can expect updates on the initiatives progress and will have the opportunity to help it take shape by offering their perspectives on some of the remaining unanswered questions.
